



## PRIVACY POLICY – Customer/Supplier

**Dear Customer/Supplier,**

This is to inform you that your data will be processed in full compliance with the privacy regulations (EU Regulation 2016/679 of the European Parliament and Council of April 27, 2016) regarding the protection of individuals with regard to the processing of personal data.

### **PURPOSE OF PROCESSING**

Your data will be collected and processed for the following purposes: a) Compliance with fiscal or accounting obligations; b) Fulfillment of contractual obligations and operational and management needs, strictly related to contractual obligations; c) Management of commercial relationships to the extent necessary to best provide the requested service; d) Operational and management needs, strictly related to the provision of the requested service.

### **NATURE OF PROCESSED DATA**

The following personal data, identified as "common data," will be processed, including but not limited to: first name, last name, tax code, date and place of birth (only in the case of a direct relationship with individuals), address, phone number, email. In addition to the "common data" mentioned above, for the proper conduct of the working relationship, we need to process particular types of data, referred to as "sensitive data." In particular, this includes data from which information about health status can be inferred.

### **PROVISION OF DATA**

Under Article 6 of the GDPR 679/2016, the processing for the purposes referred to in points a), b), and c) is carried out by the Data Controller within the scope of its legitimate activities and in compliance with the obligations established by laws, regulations, and EU legislation, or by provisions issued by authorities authorized by law and supervisory bodies. Therefore, the provision of data is mandatory. Any refusal to provide data or part of it will result in the inability to establish or continue the relationship, to the extent that such data is necessary for its execution.

### **PROCESSING METHODS AND DATA COMMUNICATION**

The provided data will be processed by the data controllers and authorized personnel, duly appointed, for the proper fulfillment of the above purposes using electronic tools and paper records, as well as with the use of security measures to ensure confidentiality and prevent unauthorized access. Your data will be stored in secure databases on our servers or on the servers of trusted suppliers who act as data processors. Such data will not be subject to dissemination and will be processed within the limits and times necessary for fulfilling legal obligations and the purposes stated above.

Your data may be communicated to the following categories of subjects, as data processors and/or independent data controllers:

- External consultants for accounting and tax compliance;
- Lawyers for legal assistance in contractual matters and dispute management;
- Entities/companies/freelancers and collaborators participating in our activities in various sectors, for needs strictly related to the above purposes;
- Credit institutions.

### EXERCISE OF RIGHTS AND DATA CONTROLLER

In compliance with the applicable regulations, you may request at any time:

- Confirmation of whether or not your personal data exists;
- Information about the content, origin, purposes, and processing methods;
- The logic applied in case of processing with the aid of electronic tools;
- The identifying details of the controller, the processors, and the subjects or categories of subjects to whom your personal data may be communicated.

Furthermore, you have the right to obtain:

- Access, copy, rectification, integration, and portability of data;
- Deletion (right to be forgotten), anonymization, or blocking of data processed in violation of the law;
- Objection, in any case, for legitimate reasons, to the processing of data related to the purpose of collection.

Under the Regulation, you also have the right to lodge a complaint with a supervisory authority. You can find the complete rights in the text of EU Reg. 2016/679, Articles 15-22, at the following link:
